

AMENDMENT Nr. 1 to the CONTRACT
about the realization of the Project Erasmus + National Authorities for
Apprenticeships:
Introduction of Elements Dual VET the Slovak Republic
Project N. 557044-EPP-1-2014-1-SK-EPPKA3-APPREN

Ministry of Education, Science, Research and Sport of the Slovak Republic (hereinafter referred to as „**Coordinator**“) and **State Institute of Vocational Education** (Hereinafter referred to as „**Beneficiary**“) agreed at this Amendment to the Agreement:

Article 5, paragraph 5 shall read:

Article 6 shall read:

1. The total expenditure to be committed for the **Beneficiary** for the period covered by this contract is estimated at **34.672,31 EUR** (including all taxes and duties).
2. The ERASMUS+ contribution for the **Beneficiary** shall be a maximum amount to **26.004,23 EUR**.

Article 7 shall read:

The **Beneficiaries** financial contribution into the project amounts to **8.668,08 EUR**.

Article 8, paragraph 1 shall read:

The **Coordinator** commits himself to carrying out payments, relating to the Erasmus+ contribution for the **Beneficiary** according to the achieved results of the tasks according to the following schedule:

- 1st payment: **62,82% of the ERASMUS+ contribution e.g. 16.335,69 EUR within 30 days after entering of the Agreement into force,**
- 2nd payment: **17,18% e.g. 4.467,69 EUR within 2 days after entering of the Amendment Nr. 1 into force.**
- Final payment: **The balance up to the 20% shall be paid within 30 days after the receipt of the payment from the Agency. Payment of the balance is conditional on the delivery of the finalised outputs according to the work plan and the relevant supporting documentation according to the Articles II.23 and II.24 of the Agreement.**

Article 15 shall read:

1. This amendment is entering into force on the day of the signature by both contractual parties and shall be effective since the day following after the day of publishing in the Central contract register which is led by the Governmental Office of the Slovak Republic.
2. This amendment is prepared in four copies, as of which two will be delivered to the **Coordinator** and two to the **Beneficiary**.
